Avoi (“we,” “our,” or “us”) respects your privacy. This Privacy Policy explains how we collect, use, and protect your information when you use the Avoi mobile application (the “App”).

1. Information We Collect

1.1 Information You Provide

We may collect information you voluntarily provide, including:

You are **not required** to provide medical, health, or diagnostic information.

1.2 Automatically Collected Information

- Crash logs and diagnostic data

We do **not** collect precise GPS location data.

1.3 Food & Scan Data

When you scan food products, we may process:

- Barcode or product identifiers
- Publicly available ingredient and nutrition data
- Your app preferences at the time of analysis

This data is used solely to provide app functionality.

2. How We Use Your Information

We use your information to:

- Provide and operate the App
- Generate personalized educational insights
- Improve app performance and features
- Communicate with you about the App
- Ensure security and prevent abuse

Avoi does **not** sell your personal data.

3. AI & Automated Processing

Avoi uses automated systems, including artificial intelligence, to generate **educational and informational insights**.

These systems:

- Do **not** provide medical advice
- Do **not** diagnose conditions
- May produce probabilistic or estimated outputs

You acknowledge that AI-generated outputs may be inaccurate, incomplete, or inappropriate for your specific situation.

4. Sharing of Information

We may share information:

- With trusted service providers (hosting, analytics, infrastructure)
- If required by law or legal process
- To protect the rights, safety, or property of Avoi

We do **not** share personal data for advertising purposes.

5. Data Retention

We retain information only as long as necessary to:

- Provide the App
- Comply with legal obligations
- Resolve disputes

You may request deletion of your account and associated data.

6. Your Rights

- Request correction or deletion
- Withdraw consent
